Today i.e 20-05-2020 at 4:25 pm received an information that on the same day at around 4:20 pm one Maruti Suzuki Alto car bearing regd. No. MN01W-5800 driven by unknown driver proceeding from Thoubal side towards Imphal along NH-102 knocked down one unknown male pedestrain and dashed at electriect pole erected at road side of kiyam Siphai Babu Bazar along NH-102 due to rash or negligent riding on the part Maruti Suzuki Alto car driver. As a result of which the unknown pedestrain was received fracture injuries and driver and two occupant of Maruti Suzuki Alto Car were also received injuries on their persons and evacuated to District Hospital, Thoubal for medical treatment. The said vehicles also damaged.
