
Sir,

On 07/06/2020 it was learnt that some unknown persons pirated the Manipuri Film "Khurai Angaobi" and started circulating the pirated film. On analysis of pirated copy of the Manipuri Film "Khurai Angaobi", it was come to know that Film "Khurai Angaobi" was pirated/recorded from a mobile handset bearing IMEI No. 862648040739008 having mobile No. 8131900553, which is registered in the name of Md. Sagir Khan aged about 19 yrs S/o Md. Kabul of Lilong Dam Makhong, who is also a customer of MFDC. The above named accused person unlawfully stole and infringed the work of MFDC. He prevents the profit from the purchase of Film "Khurai Angaobi" from going to the creator. He also cheated MFDC and knowingly, infringed the Copyright Act.

It is therefore, requested kindly to take up necessary legal action against the above name accused person.
