Today i.e. 20/06/2020 at 11:00 pm received reliable information that on the same day at about 10:50 pm some unknown individuals violated the ongoing Lock Down imposed and gathered disorderly in front of Grocery cum Paan Dukan of one Nasir Khan, located at Lilong Khunou near Lilong Toll Tax post, without any valid reasons. It is also reported that the unknown persons violated Lock Down SOP issued in c/w COVID-19 pandemic, by Govt. of Manipur. Immediately, I along with my team rushed at the spot and trying to disperse the unauthorized gathering. While Police team was dispersing the public gathered there, one person later identified as Md. Nashir Hussain aged about 35 yrs S/o (L) Md. Feizuddin of Lilong Khunou repeatedly pushed me and deterred me from discharging my duty. He obstructed the Police team in discharging of public function. He intimidated the public gathered there not to disperse. When Police team tried to apprehend him, he took out one pointed brass knuckle and showed us with a threat of injury. At the end, Police team managed to overpower him and snatched the pointed brass knuckle. Hence, he was arrested at 11:20 pm and seized the pointed brass knuckle at 11:25 pm.

So, a suo motto case under **FIR No. 60(6)2020 LIL.-PS U/s 186/188/189/353** **IPC** has been registered for investigation.
