

Today i.e 10-6-2020 at 11:20 am received information that on the same day at around 11:10 a.m one KTM DUKE bike b/ regd No. MN01F-0226 and one Kawasaki Caliber bike b/ regd No. MN01M-5750 ridden by an unknown riders proceeding from Tentha Side towards Wangjing side along IVR Wangjing Tentha road hit at the back side of one parked Maruti Suzuki Swift car b/ regd No. -NIL at Wangjing Tentha road near Nungphou Bazar due to rash or negligent riding on the part both KTM DUKE Bike and Kawasaki Caliber bike. As a result of which the unknown riders of KTM Duke and Kawasaki Caliber bike and one unknown pillion rider of KTM Duke Bike were received injuries on their persons and evacuated to District Hospital, Thoubal for medical treatment. As well as three vehicles were also partly damaged.

Hence, a sou-moto case under FIR No. 82(6)2020 TBL-PS U/S 279/338/427 IPC has been registered for investigation.
