Subject: Request to take appropriate action against Thokchom Samu @ Samungou Singh for threatening to kill me with dire consequences by using abusive words/language on 17-06-2020 at about 12.18 pm through phone call.

Sir,

I, the undersigned, have the honour to lay down the following few humble lines for your kind perusal and necessary action.

1. That I am serving as a Child Marriage Prohibition Officer, Thoubal, Department of Social Welfare, Government of Manipur.
2. That on receiving an application dated 09-06-2020 to prevent a proposed child marriage from the "Youth Forum for Protection of Human Rights, Imphal" (copy enclosed). I along with a team of police headed by the O.C. Thoubal P.S. had intervened the said child marriage on 10<sup>th</sup> of June 2020 at Khangabok. The marriage was prevented from being solemnized after counselling to the parents of the proposed bridegroom. On my effort to counsel the father of the proposed bride namely, Thokchom Samu @ Samungou Singh, he stated that he will not take back the custody of his own daughter who is presently residing at the residence of the bridegroom. Regarding this matter, the father of bride, Thokchom Samungou Singh made a call to me at about 12.18 pm on 17.06.2020 i.e. today from his mobile no. **7629 850 320** to my personal mobile no. **7005207230**.
3. That on the said telephonic conversation, he had threatened me that he will kill me saying, **"....complaint tourakeba agangdo kanano ei masak khange.... masak khange natradi nang afaba oiroy.... Nang hatkani nang hatkani eina.....ei nupane nang nupine ..."**. He was

preventing me from discharging my official duty as a Child Marriage Prohibition Officer by saying such threatening words "...noigi court ki sangsthanna karigidamakta moida hanjan hanjan chatpano eidi ichado inthoc-khrena....". Further, he intended to outrage my modesty by using abusive words, "...sala hui .....which person nang karam ba mino nang gadha ra hui .....nupi haibase nupagi makha thangbane nang kaoganu, nang khangu....". He offered to bribe me a lot of money by using such words "....Peisa pamladi peisa lupa lakh pambra, crore pambra ei pige lao..... nang inakta nang peisa pamme louru lao", (Copy of the Call record is enclosed)

4. I, therefore request you to kindly take appropriate action against the accused persons at the earliest possible.
