Subject : Report

Sir,



I have the honour to state that today i.e. 03/07/2020 at about 2:10 pm, received specific information that one Lhingkhonie Haokip R/o Songdo Village, Henglep and one Lemthang Vaiphei @ Thangpoi, R/o Tuibong Village are trafficking Heroin (No.4) in and around Tuibong Bazar in a Vehicle bearing No. MN-03A/3880. Accordingly, the information was reduced to writing and the same was forwarded to SP/NAB-PS.


1. That, under the supervision of Addl. SP/NAB, Manipur, a team of NAB-PS led by OC/NAB-PS rushed at the said area with necessary equipments (testing kits, weighing scale etc.).
2. That, on reaching Tuibong Bazar, the Vehicle (MN-03A/3880) which the source feed came along Churachandpur to Imphal road. The vehicle was halted and found two occupants-one driver and a lady. They were identified as (1) Lhingkhonie Haokip (49) W/o (L) Thangjang Haokip, R/o Songdo Village, Henglep, Churachandpur District, Manipur and (2) Lemthang Vaiphei @ Thangpoi (34), S/o (L) Paocha Vaiphei, R/o Tuibong Village, Churachandpur District, Manipur. It is to mention here that before their identification, we introduced ourselves as Police personnel of NAB-PS.
3. That, by observing every required formalities, checking of the two detainees and the vehicle were conducted. In that, one yellow and black coloured carton box was found keeping at the lap of the lady (Co-driver). On checking the box, it was found to contain 30 caps of different colours-12 pink coloured caps, 7 green coloured caps, 7 blue coloured caps and 4 red coloured caps. Further, on checking each cap is found to contain light brown coloured powder, packed in transparent polythene. Each packed weighs 12.5 grams and thus the total weight of the 30 packets of suspected Heroin (No.4) is 375 grams, including the weight of transparent polythene. *It is pertinent to mention here that during the search there were no independent witnesses available as there was none willing to witness the search procedural drill.*
4. That, on preliminary test the powder with the testing kits, the powder shows positive results of Heroin (No. 4). Further, on checking the belongings of Lhingkhonie Haokip, one SBI ATM Card bearing No. 4592 0002 5244 2146 that stands in the name of L. Haokip, one PAN Card having No. ANLPH 3841 E, one Mobile Phone Handset having IMEI Nos. 861261041039419 and 861261041039427, and a sum of Rs. 20,000/- (Rs. Twenty Thousands) only were found in her lady hand bag, brown in colour. Thus, the above items viz. 30 caps containing heroin powder, ATM card, PAN Card, Mobile Phone Handset and a sum of Rs. 20,000/- all contain inside her land bag were seized at 4:10 pm from the possession of Lhingkhonie Haokip (49) W/o (L) Thangjang Haokip, R/o Songdo Village, Henglep, Churachandpur District, Manipur, by observing formalities.

5. That, from the possession of the driver namely Lemthang Vaiphei @ Thangpoi (34), S/o (L) Paocha Vaiphei, R/o Tuibong Village, Churachandpur District, Manipur, one Mobile Phone Handset having IMEI Nos. 869444037182763 and 869444037182771 and the vehicle HONDA CRV (white in colour) bearing registration No. MN-03A/3880 were seized by observing formalities at 4:20 pm.
6. That, in the light of the above facts, Lhingkhonie Haokip (49) W/o (L) Thangiang Haokip, R/o Songdo Village, Henglep, Churachandpur District, Manipur and Lemthang Vaiphei @ Thangpoi (34), S/o (L) Paocha Vaiphei, R/o Tuibong Village, Churachandpur District, Manipur, are arrested at 4:30 pm.

The arrested accused persons and the seized are, therefore, handed over to you for taking necessary legal actions against them.
