On 25/06/2020 at around 10:00 pm two teams of Lilong P.S. led by Insp. Oinam Ajit Singh, OC/LH. PS assisted by SI Md. Isha Khan and ASI Laishram Likendru of Lilong P.S under the supervision of SP, Thoubal conducted normal Patrolling along IVR Lilong Turel Ahanbi Dam road. At about 10:20 pm, when our police team arrived at Lilong Turel Ahanbi road near Sirinthong some unknown persons were found standing in a very suspicious manner and one of them was holding one black polythene bag. Seeing our police team approaching, suddenly the unknown persons ran away from the spot in different directions in a very suspicious manner. On seeing their suspicious nature our police team chased and managed to detain the person who was holding the black polythene bag for verification while the other persons escaped taking the advantage of darkness. On verification of the detained person, he identified himself as one **Md. Farooque (37) yrs.** S/o Md. Anwar Ali of Lilong Turel Ahanbi Ubakthong Makha. And he was holding one black colour polythene containing some suspected items. On opening the black polythene, found 12 nos. of red colour soap caps, 7 nos. of blue colour soap caps and 1 (one) green colour soap cap and each soap cap was found containing yellowish powder substances suspected to be Heroin No. 4, packed in transparent plastic pouch. Thus altogether 20 nos. of soap caps found in the black colour polythene bag. The 12 nos. of red colour soap caps were marked as R1, R2, R3, R4, R5, R6, R7, R8, R9, R10, R11 and R12 for identification. Similarly 7 nos. of blue colour soap caps were marked as B1, B2, B3, B4, B5, B6, B7 and the green colour soap cap is marked as G1.

On weighing, the powder substances containing in 12 (twelve) nos. of red colour soap cap, it weighed 12.01 grams for R1, 11.2 grams for R2, 10.9 grams for R3, 11.4 grams for R4, 11.1 grams for R5, 11.4 grams for R6, 11.4 grams for R7, 11.7 grams for R8, 11.6 grams for R9, 11.1 grams for R10, 10.9 grams for R11 and 12.1 grams for R12 including the weight of the thin plastic pouches.

On weighing the suspected Heroin No. 4 contained in 7 nos. of blue colour soap caps, it weighed 11.6 grams for B1, 12.5 grams for B1, 11.3 grams for B3, 11.9 grams for B4, 11.5 grams for B5, 11.6 grams for B6 and 11.8 grams for B7 respectively including the weight of the thin plastic pouches. Similarly on weighing the weight of the yellowish powder substances contained in the green colour soap cap found 11.6 grams for G1 including the weight of the thin plastic pouch.

Therefore, the arrested person namely **Md. Farooque (37) yrs.** S/o Md. Anwar Ali of Lilong Turel Ahanbi Ubakthong Makha was arrested on the spot at 10:50 pm and seized the said drugs from the unauthorised possession of the arrested person at 11:05 pm. Reported the matter to senior officer.

Hence a case under FIR No. 61(06)2020, LH. PS U/S 21(b)/29 ND & PS Act is registered for investigation.
