Sub: request to lodge FIR against one Md. Islamuddin (50yrs aged) S/O (L) Md. Ali, resident of Lilong bazar for physically assaulting Md. Salman, computer operator MSPDCL prepaid recharge counter

Sir,

With regard to the mentioned subject matter, I am submitting a true report on the incident of physical assault that occurred in the office premises, leading to hospitalization of my staff – Md. Salman, for your kind consideration and needful action by registering a FIR against the assaulter – Md. Islamuddin.

Report:

- 1) On the 4th July, 2020 at around 2 p.m., while Md. Salman, computer operator(recharge vending counter) was performing his normal duty, an altercation occurred with a person named Md. Islamuddin (50yrs) S/O (L) Md. Ali resident of Lilong bazar.
- 2) Following the altercation, the accused Md. Islamuddin broke the window glass of the vending counter intentionally in an attempt to physically assault and cause injury to Md. Salman (computer operator in vending counter)
- 3) The physical assault by Md. Islamuddin caused severe head injury to Md. Salman, who is at present hospitalized at RIMS.

Therefore, in view of the above mentioned report on physical assault, I am to request you again to register a FIR against the culprit – Md. Islamuddin at the earliest to deter such crimes from happening against my staff who are working day & night to provide 24/7 power supply in public interest.
