Subject: Report.

Sir,

I have the honour to report that on 06/07/2020 at about 02:10 am, received specific information from my personal source that two persons namely Md. Ziaul Haque aged about 27 yrs s/o (L) Md. Sanayai of Lilong Tharaorok & Md. Mustaque Khan (19) yrs, S/o. Md. Amir Khan of Lilong Tharaorok are selling illegal drugs i.e. illegal cough syrups at their houses. It is also learnt that they are staying at one house as joint family at Lilong Tharaorok and they are going to deliver some illegal cough syrups at their house itself. Accordingly, the version of the informer is recorded in writing and a similar copy of the same has been forwarded to SP/Thoubal for information. Immediately, a team of Thoubal District Police led by Inspt. O. Ajit Singh, OC/LII. PS assisted by SI Md. Wakibuddin, ASI Md. Serakhan Shah of Lilong PS and CDO/TBL team (G-59) led by HC Kh. Rambai Singh under the supervision of Addl. SP(Ops)/TBL and overall supervision of Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal rushed to the said place without obtaining search authorization as there was great chance of escaping of the offender and concealing the drug. On reaching the house the police team strictly cordoned the said house and found two individuals later identified as Md. Farooque aged about 27 yrs S/o Mv. Taher Ali of Lilong Yangbi Leikai & Md. Zakir aged about 25 S/o (L) Md. Feiju of Lilong Tolenkhun, suspected to be illegal cough syrup buyers standing at the verandah of the house. The two individuals were detained for verification. Then I called out the owner of the house and in that, 3-4 women came out of the house and suddenly, one person ran out from the house by holding one transparent polythene carry bag on his hand. Police team chased and managed to detain him. On verification, he identified himself as one Md. Mustaque Khan (18) yrs, S/o. Md. Amir Khan of Lilong Tharaorok. On asking about the polythene carry bag, he disclosed it is illegal cough syrups and he was about to sell it to the already detained two individuals namely Md. Farooque & Md. Zakir. He kept the polythene carry bag on the ground. On opening the transparent plastic carry bag, found 5 (five) nos. of "Bolirex" Cough Syrup bottles (100 ml each) and 3 (three) nos. of "DASLIN-CD+" Cough Syrup bottles (100 ml each). On calculation/weighing, one bottle of "Bolirex" contained  $10 \times 20 = 200$  mg of codeine phosphate (as per composition), altogether  $200 \times 5 = 1,000$  mg of codeine phosphate for "Bolirex" cough syrup and one bottle of "DASLIN-CD+" contained  $10 \times 20 = 200$  mg of codeine phosphate (as per composition), altogether  $200 \times 2 = 600$  mg of codeine phosphate for "DASLIN-CD+" cough syrup. Then, in presence of the witnesses, I seized the illegal cough syrup bottles from the possession of Md. Mustaque Khan (18) yrs, S/o. Md. Amir Khan of Lilong Tharaorok at 02:50 am of the day and arrested him at 03:00 am of the day. Then, Police team conducted house search and during the search, police team could not detect illegal drug. On examination, the arrested person Md. Mustaque Khan disclosed that some quantity of illegal cough syrup is kept concealed at the house of his associate namely Md. Shahid Rahaman (25) yrs, S/o. Md. Abdul Kadir of Lilong Tharaorok. On examination of detained persons namely Md. Farooque & Md. Zakir, they corroborated with the statement of arrested person Md. Mustaque Khan that they have come to buy illegal cough syrups. So, they were arrested at 03:10 am and 03:15 am of the day respectively.

As the immediate house search of the house of Md. Shahid Rahaman (25) yrs, S/o. Md. Abdul Kadir of Lilong Tharaorok is necessary, Police team proceeded to the house of Md. Shahid Rahaman at Lilong tharaorok. On reaching the house of Md. Shahid Rahaman, Police team called out the family members of the house. In that, one person who identified himself Md. Shahid Rahaman (25) yrs, S/o. Md. Abdul Kadir of Lilong Tharaorok came out of the house. Then, I informed him that I have reason to belief that he had concealed some quantity of illegal cough syrup at his house and I would like to conduct house search. With his permission, Police team conducted house search and during the search of his room, found one green colour carry bag below the bed room of Md. Shahid Rahaman, containing 291 (two hundred ninety one) nos. of "KING" Cough Syrup bottles (100ml each), found one white carry bag in a plastic almirah containing 14 (fourteen) nos. of "Bolirex" Cough Syrup bottles (100 ml each) and 170 (one hundred seventy) nos. of "DASLIN-CD+" Cough Syrup bottles (100 ml each). On checking, each bottle of "KING", "Bolirex" and "DASLIN-CD+" Cough Syrup found containing 10 mg of codeine phosphate per 5 ml each (as per composition). On calculation/weighing, one bottle of "KING" cough syrup contained  $10 \times 20 = 200$  mg of codeine phosphate (as per composition), altogether  $200 \times 291 = 58,200$  mg of codeine phosphate for "KING" cough syrup, one bottle of "Bolirex" contained  $10 \times 20 = 200$  mg of codeine phosphate (as per composition), altogether  $200 \times 14 = 2,800$  mg of codeine phosphate for "Bolirex" cough syrup and one bottle of "DASLIN-CD+" contained  $10 \times 20 = 200$  mg of codeine phosphate (as per composition), altogether  $200 \times 170 = 34,000$  mg of codeine phosphate for "DASLIN-CD+" cough syrup. On questioning about the illegal cough syrup bottles, Md. Shahid Rahaman stated that the detected illegal cough syrup, he disclosed that he, Md. Ziaul Haque and arrested person Md. Mustaque Khan are partners of this drug business. They collectively sell illegal cough syrup for their wrongful gain. Then, in presence of the witnesses, I seized the illegal cough syrup bottles from the possession of Md. Shahid Rahaman (25) yrs, S/o. Md. Abdul Kadir of Lilong Tharaorok at 03:35 am of the day and arrested him at 03:40 am of the day.

So, the arrested persons along with the seized articles are handed over to you for further necessary action.
