
I have the honour to stated that today i.e. on 12/07/2020 at about 01:00 pm, based on a specific input received from my source stating that a gang of vehicle lifters were loitering in a Maruti Alto LXI, silky silver colour bearing registration No. MN05A-6996 at **Lilong Chingjao area** with an ulterior motive for selling/disposal of stolen vehicles. Accordingly, I along with a team of Lilong PS led by Inspector Dinam Ajit Singh, OC Lilong PS assisted by SI Kh. Santosh Singh and SI Md. Isha Khan of Lilong PS along with members of ANJUMAN under the supervision of SP, Thoubal rushed to Lilong Chingjao area. On reaching the Lilong Chingjao area, the said Maruti Alto LXI, silky silver colour bearing registration No. MN05A-6996 and one Royal Enfield, red in colour bearing registration no. MN01AE-0040, chassis no. ME3U3S5C1JA247843, engine no. U3S5C1JA264740 were found parking at the road side of Lilong Chingjao, in a suspicious manner. Two persons were found sitting inside the car. On verification, they identified themselves as **Md. Islao Rahaman @ Momocha 25 years** S/o Abdul Hakim of Lilong Haoreibi Makha Leikai and **Md. Mujid Khan 21 years** S/o Mohammed Khan of Lilong Haoreibi Makha Leikai. On spot enquiry, they disclosed that they are vehicle lifters. On asking about the Alto LXI car bearing registration No. MN 05A-6996 and Royal Enfield, red in colour bearing registration no. MN01AE-0040, chassis no. ME3U3S5C1JA247843, engine no. U3S5C1JA264740, they disclosed that the Alto Car belonged to Md. Islao Rahaman @ Momocha and Royal Enfield, red in colour bearing registration no. MN01AE-0040, chassis no. ME3U3S5C1JA247843, engine no. U3S5C1JA264740 was a stolen vehicle. They were looking for a customer to sell it (Royal Enfield) out. They used the Alto LXI car bearing registration No. MN05A-6996 in stealing the Royal Enfield. They also disclosed that they had delivered one stolen Royal Enfield, gunmetal grey in colour bearing registration no. MN01AH-4492 to one **Md. Ziaur Rahaman @ Yaima @ Sirajuddin** (43) years S/o (L.) Md. Abdul Hakim of Lilong Haoreibi Mayai Leikai. So, **Md. Islao Rahaman @ Momocha 25 years** S/o Abdul Hakim of Lilong Haoreibi Makha Leikai and **Md. Mujid Khan 21 years** S/o Mohammed Khan of Lilong Haoreibi Makha Leikai were arrested on the spot at 02:30 pm and also seized the Maruti Alto Alto LXI, silky silver colour bearing registration No. MN05A-6996, engine no. F8DN7768140 and chassis no. MA3EYD81S00182442 and Royal Enfield, red in colour bearing registration no. MN01AE-0040, chassis no. ME3U3S5C1JA247843, engine no. U3S5C1JA264740 from the possession of **Md. Islao Rahaman @ Momocha 25 years** S/o Abdul Hakim of Lilong Haoreibi Makha Leikai at 02:40 pm.

On follow up action, the combined team along with the arrested persons proceeded to the house of **Md. Ziaur Rahaman @ Yaima @ Sirajuddin** 43 years S/o (L.) Md. Abdul Hakim of Lilong Haoreibi Mayai Leikai. On the way the said **Md. Ziaur Rahaman @ Yaima @ Sirajuddin** was found at Lilong Haoreibi Turel Ahanbi Ubakthong (identified by arrested person **Md. Islao Rahaman @ Momocha**). **Md. Ziaur Rahaman @ Yaima @ Sirajuddin**

was found standing along with two unknown persons who later identified themselves as **Md. Illiyas 24 years S/O (I.) Ayub Khan** of Lilong Haoreibi Makha Leikai and **Md. Shahbuddin @ Iboyai 55 years S/O (I.) Md. Abdur Rahaman** of Lilong Haoreibi Makha Leikai. And the stolen Royal Enfield, gunmetal grey in colour bearing registration no. MN01AII-4492 was also found on the spot. On spot enquiry, **Md. Ziaur Rahaman @ Yaima @ Sirajuddin** disclosed that he had received the said Royal Enfield through **Md. Illiyas 24 years S/O (I.) Ayub Khan** of Lilong Haoreibi Makha Leikai and **Md. Shahbuddin @ Iboyai 55 years S/O (I.) Md. Abdur Rahaman** of Lilong Haoreibi Makha Leikai. Therefore, **Md. Ziaur Rahaman @ Yaima @ Sirajuddin 43 years S/o (I.) Md Abdul Hakim** of Lilong Haoreibi Mayai Leikai, **Md. Illiyas 24 years S/O (I.) Ayub Khan** of Lilong Haoreibi Makha Leikai and **Md. Shahbuddin @ Iboyai 55 years S/O (I.) Md. Abdur Rahaman** of Lilong Haoreibi Makha Leikai were arrested on the spot at 03:40 pm and also seized the Royal Enfield, gunmetal grey in colour bearing registration no. MN01AII-4492, chassis no. ME3U3S5C2KG586162 and engine no. U3S5C2KG572009 on the spot at 03:50 pm.

Hence, all the seized vehicles and the arrested persons were brought at Lilong Police Station and handed over to you for further necessary legal action.
