Sir, I have the honour to report that I am a pensioner and on 31/05/2020 I have a sum of Rs 1937166/- (Rupees Nineteen Lakh thirty seven thousand and one hundred sixty six) only for my saving account no-117467-36670 of SBI Thoubal branch. That on 01/07/2020 at 11:30 am while I update my account balance at SBI Thoubal branch and found Rs 1177268/- (Rupees Eleven lakh seventy seven thousand and two hundred sixty eight) only. Further it is learnt that my ATM card had been stolen away by unknown person while withdrawing a cash from ATM booth located at SBI, ATM booth DC gate by delivering one ATM card standing in the name of Ngangom Nimai Meitei. The said unknown person debited a sum of Rs 679898/- (Rupees Six lakh seventy nine thousand and eight hundred ninety eight) during the period 01/06/2020 to 01/07/2020 from different ATM booths in different date and hrs from my said account. Thus, the unknown person stolen my ATM card and cheated.

It is therefore requested for kindly take up necessary legal proceeding to find out my stolen money and to punish the unknown culprit at the earliest.
