

Today i.e. 19/07/2020 at around 03:00 pm, received a specific information from one source that one Md. Wahidur Rahaman (50) S/O Md. Heshamuddin of Lilong Haoreibi Awang Leikai is selling illegal Heroin No. 4 at his house. Accordingly the said information is taken down in writing and sent a copy to SP Thoubal. Also I informed my superior officers through mobile phone. Accordingly, a team of Lilong PS led by me assisted by ASI Laishram Tikendro Singh and ASI Md. Sera Khan Shah along with the volunteers of All Lilong Anti-Drug Association (ALADA) rushed to the house of Md. Wahidur Rahaman (48) S/O Md. Heshamuddin of Lilong Haoreibi Awang Leikai with obtaining search authorization as there is chance of escaping the culprit and concealing the illegal drugs. As soon as our team reach the house of Md. Wahidur Rahaman, our police team cordoned the house very strictly. Before entering the house one who later identified himself as Md. Wahidur Rahaman (50) S/O Md. Heshamuddin of Lilong Haoreibi Awang Leikai came out of the house holding one transparent bottle and on seeing our police team he quickly threw away the bottle in a very suspicious manner. Then our team picked up the bottle containing some yellowish powder suspected to be Heroin No. 4. On weighing the suspected heroin no. 4, it weight 6 grams excluding the weight of the transparent bottle. On further searching the house, found one DBBL gun marked as "NEW LIGHT ART WORKS" bearing no. 67406-2007 along with one license. Then the 6 grams of suspected Heroin no. 4 and the DBBL gun bearing no. 67406-2007 were seized on the spot from the possession of Md. Wahidur Rahaman (50) S/O Md. Heshamuddin of Lilong Haoreibi Awang Leikai at 03:30 pm and subsequently arrested him on the spot at 03:40 pm.

Hence the above seized drugs and the arrested person were brought to Lilong PS and a suo moto case under FIR No. 66(07)2020, LIL PS U/S 21(b)/25 ND & PS Act and 27 Arms Act is registered for investigation.
