Today i.e. 19/07/2020 at around 03:30 pm, a team of Lilong PS led by me assisted by ASI Laishram Tikendro Singh and ASI Md. Sera Khan Shah along with the volunteers of All Lilong Anti-Drug Association (ALADA) were coming back to Lilong PS after seizing 6 grams of suspected Heroin no. 4 from the possession of one Md. Wahidur Rahaman (48) S/O Md. Hesaruddin of Lilong Haoreibi Awang Leikai. When our team reached the IVR of Lilong Sambrukhong Makok found one Hyundai i20 car, red in colour bearing registration no. MN 06 LA-7879 was found parking at the roadside. On seeing our police team, approaching, one unknown person came out of the driver side of the vehicle and ran away in a very suspicious manner. Then our police team chased him and detained him. On verification he identified himself as Md. Aslam Khan (32) S/O Abdul Hei of Lilong Sambrukhong Awang Leikai. Then our police team conducted thorough search of the vehicle i.e. Hyundai i20 car, red in colour in the presence of the civil witnesses and the detained person. In that found 3 nos. of blue colour pouches containing some suspected illegal items. The 3 blue colour pouches were marked B1, B2 and B3 for identification. On opening the blue colour pouch marked as B1 contains 200 nos. of small red colour suspected WY tablets weighing 21.0 grams excluding the weight of the blue colour pouch. Similarly, B2 contains 150 nos. of small red colour tablets suspected WY tablets weighing 14.6 grams excluding the weight of the blue colour pouch and B3 contains 192 nos. of small light-pink colour tablets suspected WY tablets weighing 18.6 grams excluding the weight of the blue colour pouch. Altogether 542 (five hundred forty two) nos. of suspected WY tablets. Therefore all the above mentioned illegal items i.e. 542 (five hundred forty two) nos. of suspected WY tablets in 3 nos. of blue colour pouches and the Hyundai i20 car, red in colour bearing registration no. MN 06 LA-7879, engine no. G4LAAM318578 and chassis no. MALBB51BLAM136703 were seized from the possession of Md. Aslam Khan (32) S/O Abdul Hei of Lilong Sambrukhong Awang Leikai at 04:00 pm and also arrested him on the spot at 04:05 pm in the presence of the witnesses.

Hence all the above seized items and the arrested person were brought to Lilong PS and registered a suo moto case under FIR No. 67(07)2020, LIL PS U/S 22(b)/25/60(3) ND & PS Act is registered for investigation.
