Sir,

I have the honour to state that on 23/07/2020 at about 1.30am while I was sleeping at my house, I heard quarelling sound between my husband namely Md.Taj Khan 40yrs S/o Late Md. Turab Ali of Lilong Leihaokhong and Md. Firoj Khan 42yrs S/o Md.Abdul Manan @ Namacha of of Lilong Leihaokhong infront of my house. On hearing it, immediately, I wake up & went out of the house. I saw my husband and Md. Firoj Khan 42yrs were snatching one long sword each other. Md. Firoj Khan 42yrs pulled the sword and in that, right hand palm of my husband was received injury. On seeing blood coming out from the right palm of my husband, I yelled on top of voice "MEE HATLE" "MEE HATLE". Suddenly, my brother in law namely Md.Habibur @ Habiman 35yrs also came out from the house & intervened the matter. Md.Firoj Khan 42yrs attacked/chopped my brother in law with his long sword again and again. Due to injury, my brother in law fell down on the ground and Md. Firoj Khan 42yrs fled away from the spot with his long sword. As a result of which, my husband & my brother in law Md.Habibur @ Habiman 35yrs received injury on their persons and evacuated to Rural Hospital & Research Institute, Lilong Bazar and JNIMS, Hospital Porompat respectively. Now, my brother in law is in a critical condition & he is hospitalizing at JNIMS, Hospital Porompat.

Therefore, you may kindly take further necessary legal action against the culprit Md. Firoj Khan 42yrs S/o Md.Abdul Manan @ Namacha of of Lilong Leihaokhong.I shall remain ever thankful to you for your kindness.
