On 28/07/2020 at around 11:00 pm two teams of Lilong P.S. led by Inspt. Oinam Ajit Singh, OC/LIL PS assisted by SI Md. Isha Khan and ASI Laishram Tikendro of Lilong P.S. under the supervision of SP, Thoubal conducted normal Patrolling in and around the jurisdiction of Lilong PS in order to impose prevailing curfew strictly in connection with COVID-19 and when our police team arrived at Lou Manga two youths were seen walking in a very suspicious manner when our team asked to stop them. They run in different direction however they were detained with the help of locality. On verification of the detained persons, they identified themselves as one **Md. Muddin @ Mamei (20) yrs.** S/o Md. Ayaj @ Riyas of Lilong Sambrukhong Mayai and **Md Ziaur Rahaman @ Sarif (19) yrs.** S/o Md. Aatur Rahaman of Lilong Chingkhram Makha. Then I randomly check the pockets of Md. Muddin @ Mamei (20) yrs. S/o Md. Ayaj @ Riyas of Lilong Sambrukhong Mayai before giving him option, in that detected one pink colour soap cap containing some yellowish powder wrapped with thin transparent polythene suspected to be Heroin no. 4 inside right side pocket of his blue colour long pant. On weighing, the powder substances containing in pink colour soap cap, it weighed 12.2 grams including the weight of the thin plastic.

Therefore, the two persons namely **Md. Muddin @ Mamei (20) yrs.** S/o Md. Ayaj @ Riyas of Lilong Sambrukhong Mayai and **Md Ziaur Rahaman @ Sarif (19) yrs.** S/o Md. Aatur Rahaman of Lilong Chingkhram Makha were arrested on the spot at 11:40 pm and 11: 45 pm respectively and seized the said drugs from the unauthorised possession of the arrested person namely **Md. Muddin @ Mamei (20) yrs.** S/o Md. Ayaj @ Riyas of Lilong Sambrukhong Mayai at 11:55 pm. Reported the matter to senior officer.

Hence a case under **FIR No. 69(07)2020, LIL-PS U/S 21(b)/29 ND & PS Act** is registered for investigation.
