



It has been reported that Shri K. Nando Singh, Driver/CMO office, a resident of Charangpat Mayai Leikai was assigned/given duty for transportation of COVID-19 positive persons yesterday i.e. 7th August, 2020. However, he refused/failed to perform his duty without informing and giving any reason to his controlling officer which caused immense discomfort/suffering to COVID-19 positive persons and also derailed the normal process of transportation of COVID-19 positive persons to the designated CCC (Covid Care Centre).

In this regard, you are, therefore, requested to arrest him and booked under Section 56 of The Disaster Management Act, 2005.
