

I have the honor to report that on 19/08/2020 at around 9:30 pm, while I was walking at the entrance gate of my house suddenly assaulted me by using stick & logs without proper reason by the accused persons namely

② Yumnam Ibungobi Singh (60) yrs F/o Y. Suraj Singh all are resident of Kiyam Siphai Kheng Ahanki. As a result I was bleeding injury on my head and evacuated to Hospital for giving medical treatment.

It is, therefore, requested kindly take up necessary legal action against the accused persons.
