I have the honour to report that on 06-09-2020 at about 8:30 pm, one Ahongshaangbam Bameha @ Bameh Singh 35 yrs S/o late A. Koireng Singh of Thoubal Ningombam Utha Leirak stabbed my elder brother Moirangthem Ragen Singh 51 yrs S/o late M. Heramot Singh of Thoubal Ningombam Mayai Leikai on his abdomen and left hand wrist using a knife at a Meira paibi shed located at Thoubal Ningombam Utha Leirak without valid reason. As a result of which my elder brother sustained bleeding injuries over upper abdomen and left hand wrist and evacuated to the hospital for medical treatment.

It is therefore, requested you to kindly take up necessary legal action into the matter.
