Subject: - Report.



Sir,

I have the honour to report that today i.e. 12/09/2020 at about 3:30 pm combine teams of CDO Unit, Thoubal assisted by Hav. Md. Kamal Hassan of 7th IRB now attached with CDO/TBL led by Shri Sachidananda Soibam, MPS Addl. SP(Ops)/TBL, Inspt. N. Sadananda Singh, Officer-in-Charge, Commando Unit Thoubal, and Thoubal PS team led by SI O. Inaobi Singh, SI A. Premjit Singh and ASI W. Boboy Singh of District Police, Thoubal under the supervision of Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal, District conducted frisking and checking at Thoubal Bazar area in order to detect movements of anti social elements and transportation of illegal items. While conducting frisking and checking, our team saw one scooter TVS NTORQ 125 met blue in colour bearing registration no. MN04G 0230 proceeding from Wangjing towards Lilong side and one Dio grey in colour without registration number proceeding from Lilong side towards Wangjing side were trying to exchange their vehicles in a very suspicious manner. Due to their suspicious nature, the scooters were stopped for verification and identification.

On preliminary verification, the unknown youths identified themselves as (1) Md. Boramdin(29) s/o. Md. Abdul Hamid of Moreh ward No. 7 Turel Wangma Leikai a/p Sora Mamang Leikai, (2) Bm Rashid Ahamed(25) s/o. Abdul Hakim of Lilong Hangamthabi and (3) Md. Abdul Manan(34) Md. Abdul Shamat of Moreh ward No. 7 Turel Wangma Leikai. On body searched, one Redmi 6A with 1(one) Voda SIM card were detected from the possession of person note at Sl. No.1 above, one i-Phone with one Jio SIM card were detected from the possession of person note at Sl. No. 2 above and one MI 8-Pro with 2(two) SIM cards i.e. Jio & Airtel SIM cards were detected from the possession of person note at Sl. No. 3 above.

On further checking the TVS NTORQ 125 scooter bearing registration no. MN04G 0230, by opening different parts of the body of the scooter 15 (five) small black packets tight with white transparent sellotape containing of suspected WY tablets was detected at the instance of Md. Abdul Manan(34) Md. Abdul Shamat of Moreh ward No. 7 Turel Wangma Leikai from different parts of the scooter TVS NTORQ 125 which was ridden by him. On weighing the suspected packets of WY-Tablet one after another, found to be weighing (1) 0.235 grams (2) 0.240 grams, (3) 0.235 grams, (4) 0.240 grams, (5) 0.240 grams, (6) 0.240 grams, (7) 0.235 grams, (8) 0.240 grams, (9) 0.245 grams, (10) 0.240 grams, (11) 0.235 grams, (12) 0.240 grams, (13) 0.240 grams, (14) 0.235 grams and (15) 0.245 grams respectively including the weight of wrapped plastics is 3.585 kg.

Finally, all the items suspected to be WY tablets and TVS NTORQ 125 scooter bearing registration no. MN04G 0230 and 1 (one) mobile handset were seized by preparing a formal seizure memo at 03:50 p.m. from the possession of Md. Abdul Manan (34) s/o. Md. Abdul Shamat of Moreh ward No. 7 Turel Wangma Leikai and 2(two) nos. of mobile handsets and one Dio grey in colour without registration number were seized from Md. Boramdin (29) and Bm Rashid Ahamed (25). Hence, Md. Abdul Manan (34) Md. Abdul Shamat of Moreh ward No. 7 Turel Wangma Leikai, (2) Md. Boramdin(29) s/o. Md. Abdul Hamid of Moreh ward No. 7 Turel Wangma Leikai a/p Sora Mamang Leikai and (3) Bm Rashid Ahamed(25) s/o. Abdul Hakim of Lilong Hangamthabi were arrested at 04:00 p.m., 04:05 pm and 04:10 pm respectively of 12/09/2020 from Thoubal Bazar by preparing a formal arrest memo.

The arrested persons along with the seized articles have been handed over to you for taking further necessary legal action/procedures.
