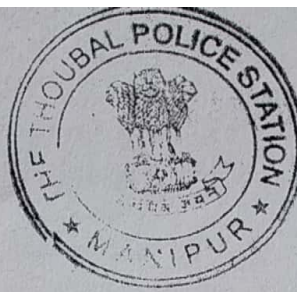

Subject: - Report.

Sir,

I have the honour to report that today i.e. 19/09/2020 at about 7.00 pm while I along with Hav. No. 132001426 W. Amarjit Singh of 1<sup>st</sup> MR attached with CDO/TBL and party led by Shri Sachidananda Soibam, MPS Addl. SP(Ops)/TBL assisted by Inspt. N. Sadananda Singh, Officer-in-Charge, Commando Unit Thoubal, under the supervision of Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal, District were on patrolling at Leishangthem Tayenjam Leikai in order to detect movements of anti social elements and transportation of illegal items. While doing so, our team saw two unknown person with one Honda Activa were found standing near Oil Pump in a very suspicious manner. Due to their suspicious nature, we immediately got down from our vehicle and asked them to rise their hands for verification and identification. One of the two person has escaped with the Activa from our commando party towards Nungei side, but our team swiftly catch one unknown person with two cartoon boxes.

On preliminary verification, the unknown person identified himself as Pusam Abdullah (29) s/o (Late) Md. Abdul Rahaman of Mayang Imphal Bengoon. He further disclosed that the person who escaped from the spot with the Activa was Md. Rasid @ Bocha (27) of Mayang Imphal Bengoon. He further disclosed that they were coming there for selling the drugs. On further checking the two cartoon boxes, found 108 (one hundred and eight) numbers of bottles mark as **Cefrex** cough syrup 100ml Chlorpheniramine Maleate and Chodeine Phosphate syrup in each boxes altogether 216 bottles. Each bottle of Cefrex cough syrup contain 10mg of codeine phosphate per 5ml each (as per composition) which is a contravened substance under ND & PS Act.

Finally, all the illegal **Cefrex** cough syrup i.e. 216 (two hundred and sixteen) were seized by preparing a formal seizure memo at 7.25 pm from the possession of Pusam Abdullah (29) s/o (Late) Md. Abdul Rahaman of Mayang Imphal Bengoon. Hence, he was arrested at 7.45 p.m. of 19/09/2020 from Leisangthem Tayenjam Leikai near Oil Pump by preparing a formal arrest memo.

The arrested person along with the seized articles have been handed over to you for taking further necessary legal action/procedures.
