Subject : Report



Sir,

I have the honour to state that today i.e. 23/07/2020 at about 3:10 pm, received specific information that some 2/3 person are trafficking Brown Sugar in and around Mahabali area, Imphal East. Accordingly, the information was reduced to writing and the same was forwarded to SP/NAB-PS.

1. That, under the supervision of Addl. SP/NAB, Manipur, a team of NAB-PS led by OC/NAB-PS rushed at the said area with necessary equipments (testing kits).
2. That, on reaching Mahabali near Nano Car Wash, the source man pointed the suspected persons who were standing on the road side. After detaining, they were identified as Denis Letjathang Chongloi (27) S/o Thomas Nahpao of H.Khopibung Village, PO-Pangei, PS-Saikul, Kangpokpi-District and Mrs Lalnu Touthang (42) W/o (L) Haopu Touthang of Paikoh Village, PS-Ukhrul, Ukhrul District, At Present- Hatta Golapati, Imphal East. It is to mention here that before their identification, we introduced ourselves as Police personnel of NAB-PS.
3. That, by observing every required formalities (option statement etc), checking of the two detainees were conducted. In that, on checking of Mrs Lalnu Touthang's lady bag (multi coloured), found one transparent polythene packet containing Brown colour powder like substance suspected to be brown sugar. Further, on weighing the packed it weighs 804 grams, including the weight of transparent polythene. *It is pertinent to mention here that during the search there were no independent witnesses available as there was none willing to witness the search procedural drill.*
4. That, on preliminary test the powder with the testing kits, the powder shows positive results of Heroin. Further, on checking the belongings of Mrs Lalnu Touthang, one N3 Mobile Handset having phone no. 7629851624 was also found. Hence, the detected 804 grams of Brown Sugar and one mobile phone handset were seized at 4:10 pm from the possession of Mrs Lalnu Touthang (42) W/o (L) Haopu Touthang of Paikoh Village, PS-Ukhrul, Ukhrul District, At Present- Hatta Golapati, Imphal East by observing formalities.
5. That, from the possession of Denis Letjathang Chongloi (27) S/o Thomas Nahpao of H. Khopibung Village, PO-Pangei, PS-Saikul, Kangpokpi-District, one Redmi Mobile Handset having phone Nos. 8132919832 and 7002154207, one black colour money

purse, one AADHAAR card in the name of Denis Letjathang Chongloi having no. 5891 4465 5482 and a sum of Rs 310/- were seized by observing formalities at 4:20 pm.

6. That, in the light of the above facts, Denis Letjathang Chongloi (27) S/o Thomas Nahpao of H. Khopibung Village, PO-Pangei, PS-Saikul, Kangpokpi-District and Mrs Lalnu Touthang (42) W/o (L) Haopu Touthang of Paikoh Village, PS-Ukhrul, Ukhrul District, at Present- Hatta Golapati, Imphal East, were arrested at 4:30 pm and 4: 33 pm respectively.

The arrested accused persons and the seized are, therefore, handed over to OC/NAB-PS, Manipur for taking necessary legal actions against them.
