On 08/08/2020 at around 06:30 pm two teams of Lilong P.S. led by Inspt. Oinam Ajit Singh, OC/LIL PS assisted by SI Md. Isha Khan of Lilong P.S. under the supervision of SP, Thoubal conducted normal Patrolling in and around the jurisdiction of Lilong PS in order to impose prevailing curfew strictly in connection with COVID-19 and when our police team arrived at Lilong Nungeiching area some localities were seen gathering at a place near Lilong Nungei mamang Masjid and when enquired, it was found that they detained one individual who was identified as Md. Najir Khan (26) S/O Md. Ibrahim of Lilong Lilong Nungeiching for selling heroin no 4 powder. They identified the individual and he was standing there holding one white small bottle and when asked he disclosed that his name is Md. Najir Khan (26) S/O Md. Ibrahim of Lilong Nungeiching and he has been selling illegal drugs heroin no.4 since some months back. He further disclosed that the white small bottle he was holding belong to him and contained heroin no 4 powder. On weighing, the powder substances containing in white colour bottle weighed 6.3 grams excluding the weight of the white colour bottle.

Therefore, the individual namely Md. Najir Khan (26) S/O Md. Ibrahim of Lilong Nungeiching was arrested on the spot at 07:10 pm and seized the said drugs from the unauthorised possession of the arrested person namely Md. Najir Khan (26) S/O Md. Ibrahim of Lilong Nungeiching at 07:20 pm. Reported the matter to senior officer.

Hence a case under **FIR No. 70(08)2020, LIL-PS U/S 21(b) ND & PS Act** is registered for investigation.
