Subject :- Report.

Sir,

I have the honour to stated that today i.e.on 29/08/2020 at about 1.00pm I along with my police party under the supervision of SP, Thoubal conducted frisking and checking at Lilong Bazar In order to impose prevailing lock down strictly in connection with COVID-19 and at about 2.30 pm one Maruti Alto Car Silver in colour bearing registration no. MN01W9866 was coming from Ushoipokpi side towards Lilong Bazar along National Highway no.102 in a very suspicious manner. Our police team stopped the vehicle and found that the car was occupied by two persons and on verification driver of the vehicle identified himself as Khwairakpam Rajeshwor Singh 35yrs S/o Kh. Ramdhon Singh of Sagolband Bijoy Govinda Mamang Leikai, and the other occupant (sitting at the front seat next to the driver) identified himself as Moirangthem Arunkumar Singh 38yrs S/o M. Priyogopal Singh of Uripok Yambrem Leikai. Then I asked them that I would like to search their body as I had suspicious that they were hiding some illegal items. In that Moirangthem Arunkumar Singh taken out a small black plastic polythene bag from right side front pocket of his half pant and he disclosed that the small black plastic polythene bag contained WY tablets. Accordingly I opened the small black plastic polythene bag and found some pink colour tablets suspected to be WY tablets. On counting it count 58 nos. and on weighing, the 58 nos.of WY tablets weighed 5.6 grams. On questioning they disclosed that the same WY tablets belong to them and the Alto car bearing no MN01W9866 belongs to the accused person Khwairakpam Rajeshwor Singh. Further they disclosed that they used to purchase such illegal drugs i.e., WY tablets from one of their associates illegal drugs seller namely Mrs. Jumera @ Abem 37yrs W/o Late Md. Helal @ Siraj Ahamed of Kaleikhong Mayai since first week of January 2020 and used the Maruti Alto Car Silver in colour bearing registration no. MN01W9866 in carrying/transporting the illegal drugs. On further questioning they disclosed that they have been using/consuming WY tablet since first week of January 2020 and as usual today i.e 29/08/2020 at about 2.00pm they purchased the 58 nos. of suspected WY tablets from their associate Mrs. Jumera @ Abem 37yrs W/o Late. Md. Helal @ Siraj Ahamed of Kaleikhong Mayai. Therefore, arrested the two accused persons at 3:00 pm and seized the 58 nos. of WY tablets from the unauthorised possession of the arrested accused person Moirangthem Arunkumar Singh 38yrs S/o M. Priyogopal Singh of Uripok Yambrem Leikai along with his mobile phone with airtel sim card mobile no.7085051051 at 3:10pm while the Maruti Alto Car Silver in colour bearing registration no. MN01W9866 was seized from the possession of the other accused person Khwairakpam Rajeshwor Singh 35yrs S/o. Kh. Ramdhon Singh of Sagolband Bijoy Govinda Mamang Leikai along with his mobile handset & airtel Sim card mobile no. 8414825646 at 3:15pm. Then immediately our police team assisted by W/SI Rajiya Shahani of Lilong Police Station raided the house of Mrs Jumera @ Abem at Kaleikhong Mayai without obtaining search warrant as there were chances of escaping the accused person Mrs. Jumera @ Abem and concealing illegal drugs if any. She was found at her house and on questioning she admitted that she sold the 58 nos. of WY tablets to the two accused persons Khwairakpam Rajeshwor Singh and Moirangthem Arunkumar Singh on 29/8/2020 at about 2:00pm at her house. Therefore she was arrested from her house along with her mobile handset and Jio sim card mobile no. 6909209524 at 4.00pm. Searched her house but no incriminating articles was found.

So, the arrested persons along with the seized articles are handed over to you for further necessary action.
