Warish Akram 14yrs along with his 9/10 friends were racing from Thoubal side towards Imphal side on reaching at Lilong Heinou Makhong along on NH/102 my son was dashed by one Diesel Auto bearing registration no. MN04D/6616 which was coming in the same direction due to rash negligent driving on the part of unknown driver of Diesel Auto. As a result of which my son received bleeding injury on his head and evacuated to Raj Medicity Hospital, Imphal for medical treatment. The said Diesel Auto was also partly damaged.
