Sir,

I have the honour to report that today i.e. 12/09/2020 at about 5:20 p.m. I along with my team assisted by Hav. No. 1207760 Ak. Rameshwor Singh of 2nd IRB now attached with CDO Thoubal, led by Shri Sachidananda Soibam, MPS, Addl. SP(Ops)/TBL and Inspt. N. Sadananda Singh, Officer-in-Charge, Commando Unit Thoubal under the supervision of Dr. S. Ibomcha Singh, MPS, Superintendent of Police, Thoubal District conducted frisking and checking at Lilong Haoreibi Chingkhram area in order to detect movements of anti-social elements and transportation of illegal items. While conducting frisking and checking, our team saw one Honda Activa 3G red in colour bearing registration No. MN01AD-1676 proceeding from Lilong Ushoipokpi towards Lilong Haoreibi Chingkhram side in a very suspicious manner. Due to their suspicious nature, the Honda Activa were stopped for verification and identification.

On preliminary verification, the unknown youths identified themselves as (1) Md. Islam Khan(19) s/o. Md. Abdul Salam of Sora Mamang Leikai and (2) Md. Jiaoul Haque (19) s/o. Md. Jalaruddin of Sora Mamang Leikai. On his body searched, detected 2(one) mobile handset along with 2(two) SIM cards i.e. Redmi 7 with one Jio SIM card bearing mobile No. 6009086621 from the possession of Md. Islam Khan(19) s/o. Md. Abdul Salam of Sora Mamang Leikai and 1 (one) Redmi 6A with one Jio SIM card bearing mobile No. 6009731850 from the possession of Md. Jiaoul Haque (19) s/o. Md. Jalaruddin of Sora Mamang Leikai. On further checking the Honda Activa bearing registration no. MN01A D1676, by opening the vehicle Tool box detected one transparent plastic containing yellowish powder wrapped with a black polythene suspected to be Heroin No. 4. On weighing the suspected Heroin No. 4 powder by using weighing machine, found to be about 50 grams approximately including the weight of the wrapped transparent plastic.

Finally, all the exhibits i.e. suspected Heroin No. 4 powder, mobile phone, Honda Activa 3G red in colour bearing registration No. MN01AD-1676 were seized by preparing a formal seizure memo at 5:50 p.m. from the possession of Md. Islam Khan(19) s/o. Md. Abdul Salam of Sora Mamang Leikai and also seized the Redmi 6A mobile handset with one Jio SIM card bearing mobile No. 6009731850 from the possession of Md. Jiaoul Haque (19) s/o. Md. Jalaruddin of Sora Mamang Leikai at 05:55 pm and later arrested them on the spot by preparing a formal arrest memo at 6:00 p.m. and 6:05 p.m. respectively of 12/09/2020 from Lilong Haoreibi Chingkhram. Then, I obtained the signature of the arrestee and witnesses on the seizure memo, arrest memo in which I myself also put my signature on the same.

In accordance with the direction of Hon'ble Supreme court in the case union of India Vs Mohanlal and Ors, 2016 Civil Appeal No. 652 of 2012, the necessary procedure shall be adhered to in the presence of Magistrate.

The arrested persons along with the seized articles have been handed over to you for taking further necessary legal action/procedures.
