Subject :- Report.

Sir,

I have the honour to report that on 24/09/2020 at about 08:45 pm received a specific input from one of my trusted informers that one **Md. Akhtar aged about 21 yrs. S/O Md. Ayajuddin of Lilong Turel Ahanbi Ubakthong Mathak** is selling illegal drugs such as cough syrup bottles at his house and now huge quantity of such illegal cough syrup bottles are at his house for selling for his wrongful gain. I have taken down the information in writing and a similar copy of the same has been forwarded to SP/Thoubal for information and further necessary action. Immediately I along a team of Thoubal District Police led by Shri Sachidananda Soibam, MPS, Addl SP(Ops), Thoubal assisted by Inspector N. Sadananda Singh OC/CDO, Thoubal, Inspector O. Ajit Singh OC/Lilong PS, Jem Md. Amin Khan, SI Ramesh, Hav Md. Kamal Hassan of CDO, Thoubal under the supervision of Dr. S. Ithomcha Singh, MPS, SP/Thoubal rushed to the said place at Lilong Turel Ahanbi Ubakthong Mathak. When our team reached at Lilong Turel Ahanbi Ubakthong Mathak near the gate of the house of Md. Akhtar, Md. Akhtar was found standing there holding one black polythene bag with an unknown person in a very suspicious manner. When they saw our police team, they run away leaving the black Polythene bag. However, our team manage to detain the other unknown person while Md. Akhtar escaped taking advantage of darkness. When questioning he identified himself as **Md. Isahque (19) yrs S/O Md. Maniruddin of Lilong Haoreibi Makha Leikai** and further he revealed that he came there to purchased illegal cough syrup bottles from Md. Akhtar. And he used i20 car (old model) bearing registration no. WB06E-2497 red in colour that was found parking nearby belongs to him and he used vehicles in transporting illegal drugs. On opening the black polythene, found 88(eighty eight) nos. of illegal Cough Syrups bottles 100 ml mark as "ANREX-CP". On checking, each bottle of ANREX-CP cough syrups bottles contains 10 mg of codeine phosphate per 5 ml each (as per composition) which is a contravened under ND&PS Act. Therefore, **Md. Isahque (19) yrs S/O Md. Maniruddin of Lilong Haoreibi Makha Leikai** was arrested on the spot at 09:15 pm and seized the said drugs from the unauthorised possession of the arrested person at 09:25 pm and also seized i20 car (old model) bearing registration no. WB06E-2497 red in colour at 09:35 pm.

Hence, all the seized vehicles and the arrested persons were brought at Lilong Police Station and handed over to you for further necessary legal action.
