Today i.e. 28/09/2020 at 10:35 am received reliable information that on the same day at around 10:30 am one Tata Truck 12 wheelers bearing Regd. No. NL01N-3682 coming from Lilong side towards Thoubal side along NH-102 dashed one Honda Activa blue in colour bearing Regd. No. MN04G-1097 coming from opposite direction at the front of 16AR camp Gate, Lilong along NH-102 due to rash and negligent driving on the part of unknown driver of Tata Truck 12 wheelers. As a result of which, the rider and occupant of the Honda Activa got serious injuries on their persons. The rider of the Honda Activa succumbed to his injuries on the spot and occupant of the Honda Activa was evacuated to the hospital for medical treatment. The involved Honda Activa is partly damaged.
