

Today i.e 17/10/2020 at 2025 Hrs received a reliable information that on the same day at around 2020 Hrs one Alto car bearing registration no. MN 05A-4135 was coming from Thoubal side towards Ushoipokpi side and one Honda Activa Grey in colour bearing registration No. MN01C 0257 which was coming from opposite direction were collided at Lilong Haorouhangamthabi along NH/102 due to rash and negligent driving on the part of both the unknown drivers of the involved vehicles. As a result of which both the rider and pillion rider of Honda Activa and the driver of Alto car received sustained injuries on their persons and evacuated to hospital for medical treatment and both the involved vehicles were also damaged.

Hence a Sou Motto case under **FIR No. 86(10)2020, LIL PS U/S 279/338/427 IPC** is registered for investigation
