Kullakpam Sajida daughter of Late Nijamuddin of Lilong Haoreibi Makha Leikai is not at all related to his office;

Whereas, it is to be stated that a thorough enquiry has been conducted and found that the office of the undersigned does not have any record of having issued any Certificate of Economically Weaker Section (EWS) and has not issued any such Certificate till date;

Whereas, any such Certificate produced by anyone under jurisdiction of the undersigned may hence be treated as forged/ fake;

And now, therefore, it is requested to all concerned to kindly inform the office of the undersigned if such cases are noticed for further necessary legal course of action.
