

I have the honour to state that today i.e., 21/11/2020 at about 08:00 am. I along with police team were deputed at Waithou Sangomsang area for duty on the strength of an information that some ammunition were found while excavating the foot hill (red soil) at Waithou hillock by the workers of GR Infra Projects Limited for road expansion of NH-102. On arrival at the said area it came to know that 324(Three twenty-four)nos. of rusty ammunition and 1(one) rusty iron chain were recovered from the waithou hillock eastern side of NH-102 during the excavating of foot hill(red soil) by the workers of GR Infra Projects Limited for road excavation. The said articles is suspected to be kept concealed by some unknown miscreants.
