

Subject :- Report.

I have the honour to report that on 21/11/2020 at 10:40 pm received a specific information from my private sources while I was on QRT duty at Lilong Haoreibi that some unknown habitual vehicle lifters have gathered at Lilong Haoreibi Turel Ahanbi Ubakthong Makha IVR near Ngangou Mapal with an ulterior motive for selling/disposal of stolen vehicles. Acting on the information, I along with my team under the supervision of SP/TBI., Addl. SP (Ops) & OC-CDO/TBI. immediately rushed to the said area and conducted search. While reaching the area, we saw that one unknown person was trying to flee away by driving one Honda Activa 6G dark grey in colour and having no registration number in a suspicious manner. As a result, the unknown individual was detained and verified. On verification, he identified himself as **Md. Azeruddin @ Aji (24) yrs. S/o Md. Allauddin of Lilong Haoreibi Awang Leikai**. On physical inspection the Honda Activa 6G Chassis No. SME4JF913CLW068441 & Engine No. JF91EW0068371 were found respectively. On preliminary examination, he disclosed that he along with his friend **Md. Wahidur Rahaman @ Sarif aged about 25 yrs. S/o Md. Fazur Rahman of Lilong Haoreibi Turel Ahanbi Darul Uloom Makha** had stolen the said Honda Activa 6G from the campus of Jama Masjid, Lilong Bazar in the evening of 21/11/2020 and the said vehicle is brought at Lilong Haoreibi Turel Ahanbi Ubakthong Makha IVR near Ngangou Mapal area for selling purpose. Hence, he was arrested at 00:15 am and seized the Honda Activa 6G at 00:20 am from the spot by observing formalities.


It is therefore, the arrested person along with the seized article is handed over to OC/Lilong PS for further necessary action.
