Sir,

I have the honour to report that on i.e 22/11/2020 at around 2:45 pm while I was staying at my working my house domestically works as usual. Suddenly, my last son namely Md. Kaif aged about 24yrs has been arguing against me and started quarrelling in presence of my family members demanding huge amount of money as well as his land share. Such events occurred in many times. He suddenly came towards me and started assaulted on my face and body by punching and kicking. In due effect suddenly fled away from the area for safety of my life and my son took a Dao (Thangjou) and chased me in fierce mood with shouting, "I will kill you just now". On seeing the scene, I shouted for help but fall slipped within a short distance. Immediately, some neighbors including my brother rushed and overpowered my son and rescued me. He was fastened tightly with iron chain and plastic rope. As a result of which, I sustained serious injury on my persons and evacuated me to the Noor Hospital, Lilong for medical treatment.

It is therefore requested kindly to take up necessary legal action against the habitually crime offender Md. Kaif.


