

I have the honour to report that on 28/11/2020 at about 05:30 pm the following culprits namely 1) Md. Alimuddin aged about 45 yrs.(Advocate) s/o (L) Md. Anshu of Lilong Chingkham Makha, 2) Md. Sarif aged about 25 yrs. s/o (L) Md. Nejamuddin of -do-, 3) Md. Tarique aged about 21 yrs. s/o Md. Siraj of -do-, 4) Md. Salman @ Salman aged about 21 yrs. s/o Md. Siraj of -do-, 5) Md. Riyajuddin @ Nahatomba aged about 45 yrs. s/o (L) Md. Ansu of -do-, 6) Mrs. Samila aged about 30 yrs. w/o Md. Riyajuddin @ Nahatomba of -do- & 7) Mrs. Rahamtun aged about 48 yrs. w/o (L) Md. Nejamuddin of -do- criminally trespassed into my house located at Lilong Chingkham Makha by holding deadly weapons like long knife, pointed knife, big sticks etc. and assaulted my father namely Md. Najir Ahamed aged about 80 yrs. with attempt to murder him without giving any reason. Moreover they also assaulted me and my family members. They vandalized the household material after breaking the door and windows of my dwelling house. As a result of which, my father Md. Najir Ahamed aged about 80 yrs., Mrs. Angou aged about 25 yrs. (my wife) and myself sustained serious injuries on our persons and evacuated to the hospital for medical treatment.

So, it is therefore, requested you to take up necessary legal action against the culprits at the earliest.
