

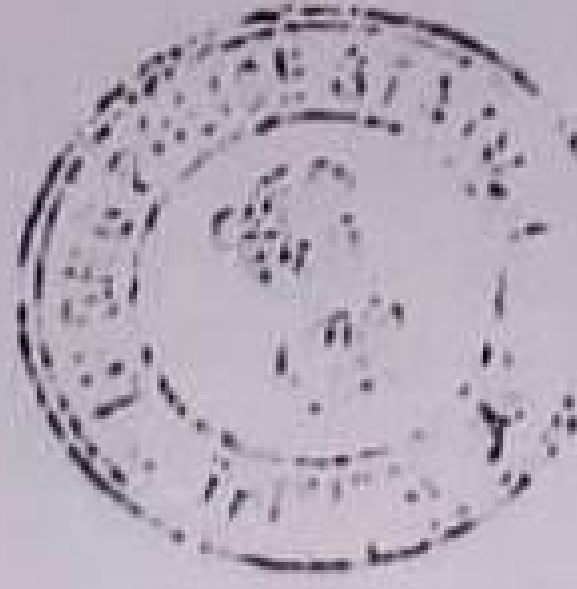


At that time of entering in our house above mentioned person namely

Md. Abdul Kalam was holding Sangin, Angou Bibi was holding Ironrod, Mrs Marem Bibi was holding knife, Md. Hefajuddin was holding spade, Md Akter Ali was holding pistol, Maraem was holding stick in their respective hands and shouted for killing our family members.

In the said incident, some of our family members were injured and we called for help in neighbour. On hearing of our hue and cry for help, some of the villager's rushed in the area and saved us. Immediately on seeing the persons for help, the above mentioned persons ran away towards their residence which is just adjacent to the said place of occurrence. Some of our persons were injured due to the said beating by the above mention persons. The injured persons were brought to the hospital for first aid. The injured are still in the hospital. Hence I am requesting your good self to take up necessary legal action by way of arresting the above name persons.

Delay in giving this information is caused due to the advice of some elders of our Locality to solve the problem.
