Sir,

I have the honour to report that on 05/12/2020 at about 7.45 pm the above noted accused persons criminally trespassed into my house located at Lilong Dam Makha by holding deadly weapons like swords, iron rod, barrel gun etc and assaulted my family members without giving any reason. Moreover they fired out 2/3 rounds of barrel gun with attempt to murder of my family members. As a result of which, I and the following persons namely 1) Md. Salman Hussain (27) yrs (younger brother), 2) Md. Abash (28) yrs. s/o Md. Rahaman of Lilong Dam, 3) Md. Rohit (21) yrs s/o Md. Rousan of Lilong Dam, 4) Md. Aouliyas (13) yrs. s/o Md. Rousan of -do- sustained serious injuries on our persons and evacuated to Hospital for medical treatment.

It is therefore requested take up necessary legal action against the above noted accused persons at the earliest.
