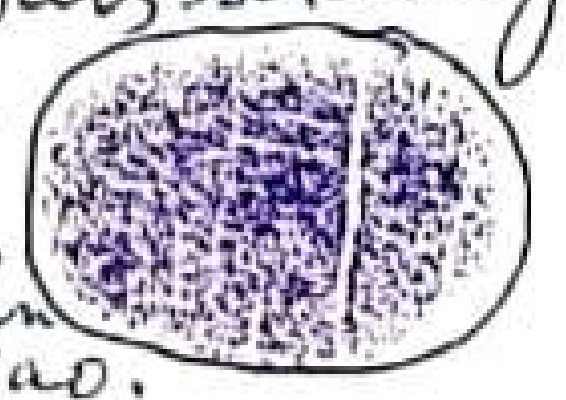
Sir,

Khondor @ Islaodden 70yrs s/o (L) Sirajuddin 6) Md. Salman Khan (25) s/o Md. Khondor, 7) Md. Rou Sam (28) s/o (L) Sajon 8) Md. Riyaj Khan (29) s/o (L) Sajon 9) Md. Subbir s/o Khondor, 10) Md. Abbas (27) s/o Rahman 11) Md. Itomba (20) s/o (L) Rajao and 12) Md. Ruhit 19yrs s/o Md.
