Today i.e. 07/01/2021 at around 03:00 pm, received a specific information from own source that one A Star car silky silver in colour bearing registration no. MN04P-0208 driven by unknown driver is coming from Lilong Bazar side towards Thoubal for transporting/selling illegal drug items. Accordingly the said information is taken down in writing and sent a copy to SP Thoubal. Further, a team of Lilong PS led by me assisted by SI W. Manitomba Singh, WSI Rajiya Shahni, WSI A. Satyapati Devi and ASI Md. Sera Khan Shah under the supervision of Addl. SP (L/O)-TBL, ASP (OPS)-TBL, SDPO/TBL and over all supervision of SP/TBL conducted frisking and checking of suspected vehicles at Lilong Alia Lamkhai along the NH-102. In that the suspected A Star car silky silver in colour bearing registration no. MN04P-0208 was seen proceeding from Lilong Bazar side toward Thoubal side in high speed. So, our police team immediately chased the said vehicle and detained the vehicle at Lilong Khunou area near Toll Tax along the NH-102. The said vehicle was found seated by one driver along with one occupant. On verification, they were identified themselves as one Md. Feroz Khan @ Khunu (46) yrs. S/o (L) Md. Anou of Thoubal Moijing Wangmataba Khong Manung driver of the car and another identified as Md. Bharot @ Alam Azad (37) yrs. S/o (L) Md. Ajeruddin of Thoubal Moijing Wangmata Makha Leikai. So, I asked them that there is sufficient reason for carrying illegal drugs on the vehicle. On further verification, both the individual also disclosed that they were carrying some illegal drugs inside their vehicle. So, I informed them verbally as well as writing about their legal right to be searched their body and vehicle before a Magistrate/ Gazetted officer or civil witnesses. They told us to conduct search of their body and vehicle before a Gazetted officer or a civil witnesses instead of producing before the Magistrate. So, I requested to Shri H. Johny Sharma (MPS) SDPO/TBL to be present during the search of the individuals and vehicle. I also informed one civil witnesses namely Md. Sayed Ahamed @ Jugunu who is the Councilor of Lilong Municipal Council to be present during the search of the individuals. In the meantime, large numbers of general public were gathering at the spot as well as vehicular traffic jam occurred. Accordingly, inconvenient for searching of the individual and vehicle at the spot was occurred. So, the individuals along with the vehicle were brought to Lilong Police Station to conduct search of the individual and vehicle in presence of the Gazetted officer and civil witness. On arrival of Gazetted officer namely Shri H. Johny Sharma (MPS) SDPO/TBL and civil witness namely Md. Sayed Ahamed @ Jugunu who is the councilor of Lilong Municipal Council at Lilong PS, our police team conducted body search of the individuals and vehicle. In that, one black polythene was found concealing inside the vehicle beneath the left side front seat and one another black polythene was also found concealing inside the vehicle beneath the vehicle gear lever cover.


On opening, one of the black polythene was found containing 05(five) nos. of pink colour soap caps in which containing of light orange colour powder suspected to be brown sugar, packed with transparent plastic packet in each soap caps and the other black polythene bag was also found containing 10(five) nos. different colours soap caps ie 04(four) in red colours, 04(four) in green colours and 01 (one) in pink and 01(one) skyblue colour on the top and pink colour on the bottom in which containing light orange colour powder suspected to be brown sugar, packed with transparent plastic packet in each soap caps. On further verification, the individuals namely Md. Feroz Khan @ Khunu (46) yrs. S/o (L) Md. Anou of Thoubal Moijing Wangmataba Khong Manung and Md. Bharot @

Alam Azad (37) yrs. S/o (L) Md. Ajeruddin of Thoubal Moijing Wangmata Makha Leikai disclosed that the said illegal drugs were brought from Churachandpur for handing over to one of their associate business partner namely Md. Aslam Khan of Thoubal Moijing Awang Leikai. So the above mentioned illegal drugs, the A Star car silky silver in colour bearing registration no. MN04P-0208 and 02(two) mobile handsets 1) Samsung J7 bearing IMEI no. 353632099398218/02 & 353633099398217/02 and 2) MI Redmi Note8 bearing IMEI no. 861182049839636 & 861182049839644 were seized from the possession of Md. Feroz Khan @ Khunu (46) yrs. S/o (L) Md. Anou of Thoubal Moijing Wangmata Khong Manung at 04:00 pm and also arrested him at 04:10 pm by observing formalities. Further, Md. Bharot @ Alam Azad (37) yrs. S/o (L) Md. Ajeruddin of Thoubal Moijing Wangmata Makha Leikai was arrested at 04:15 pm and one (01) MI Redmi mobile handset bearing IMEI no.862183043660654 & 862183043660662 was also seized from his possession at 04:20 pm in the presence of the witnesses by observing formalities for carrying the above-mentioned suspected seized illegal drugs.

Further, a requisition has been made to the **Scientific Officer Mobile Forensic Unit, Imphal East, Thoubal Section** for examination of the seized suspected illegal drugs. Accordingly the seized article were examined by Mobile Forensic Unit team and opined as "light orange colour powder packet in plastic packet containing in plastic containers marked 1 to 15 gives positive reactions for brown sugar in the preliminary test".

Hence a suo moto case under FIR No. 01(01)2021 LIL PS U/S 21(b)/25/29 ND & PS is registered for investigation.
