Sir,

I have the honour to report that on 29/01/2021 at about 06:30 pm while I and my family member were staying in my house located at Lilong Chingkhram Tamyai, suddenly Md. Rahmatullah aged about 24 yrs. s/o Md. Majidtullah of Lilong Chingkhram Tamyai who is my younger brother entered in my house and shouted that my whole family members should leave the house immediately. He further warned that all my family members will face dire consequence if we do not vacate from the house with claiming that my homestead land is belonged to him. Then my younger brother Md. Rahmatullah assaulted me with holding a spade and he immediately fled away from my house. As a result of which, I sustained serious bleeding injury on my left side hand and evacuated to the hospital for medical treatment.

So, it is therefore requested to take up necessary legal action against the culprit at the earliest. .
