1. That, the complainant begs to submit that a complaint was filed  
before the O.C. Lilong P.S. for the offences made therein against the  
accused persons above named dated 13-08-2020. The said complaint is  
reproduce herein below:-

To,  
The O.C. Lilong P.S.

Respected Sir,

I have the honour to report that on the above noted PO and DO, the Accused No. 1 Md. Abdur Rajak along with 2/3 unknown persons came at my house and they have stolen away-

1. My ATM Card.
2. Rupees Ten Lakh i.e. 500 note of rupees 2000 note.
3. Three rud half tolas of gold.
4. Patta (Dag Chitha) of my land located at Hapta area measuring 2.5 points.

That, the above noted crime was committed under a well plan criminal conspiracy with the accused No. 2 who is my wife while the accused No. 1 is my father-in-law.

That, the accused persons have also kidnapped my two daughters namely Miss Aleema Hussain Sm. (17 years) and Miss Raniya Hussain Sm. (11 years) and their whereabouts are not known yet.

That, the accused have committed offences punishable u/s 120-B/ 379/420/365/341 IPC.

It is, therefore requested to take up necessary legal action against the accused persons and to rescue my daughters and also to recover the stolen articles.

For which act of kindness I shall remain thankful.

A copy of the complaint/Report is enclosed herewith as Annexure A-1 for reference....

2. That, inspite of repeated request made before the O.C. Lilong P.S. no positive actions have been taken by the O.C. Lilong P.S.

Having no alternative way the complaint approached the higher authority i.e. Superintendent of Police Thoubal by filing a complaint dated 05-12-2020.

A copy of the complaint is enclosed herewith as Annexure A-2 for reference.

3. That, it is apparent that inspite of the complant there has not been any positive legal actions taken up by the police authority against the accused persons.

In the circumstance the complainant had exhausted the Section 154 (1) and 154 (3) of Cr.P.C. as mandated by the Hon'ble Supreme Court of India in the case of Priyanka Srivastava and another -Vs- State of U.P. and others reported in (2015) 6 Sec 287.

In response to the direction of the Apex Court, the complainant has no alternate ways except to approach this Court to redress his grievances by way forwarding/directing the complaint case to the O.C. Lilong P.S. for taking up necessary legal actions against the accused persons under Section 156 (3) of Cr.P.C. as mandated by the circulation of Hon'ble High Court's order dated 26-04-2019 under Cril. Petition No. 03/2008 for the ends of justice.



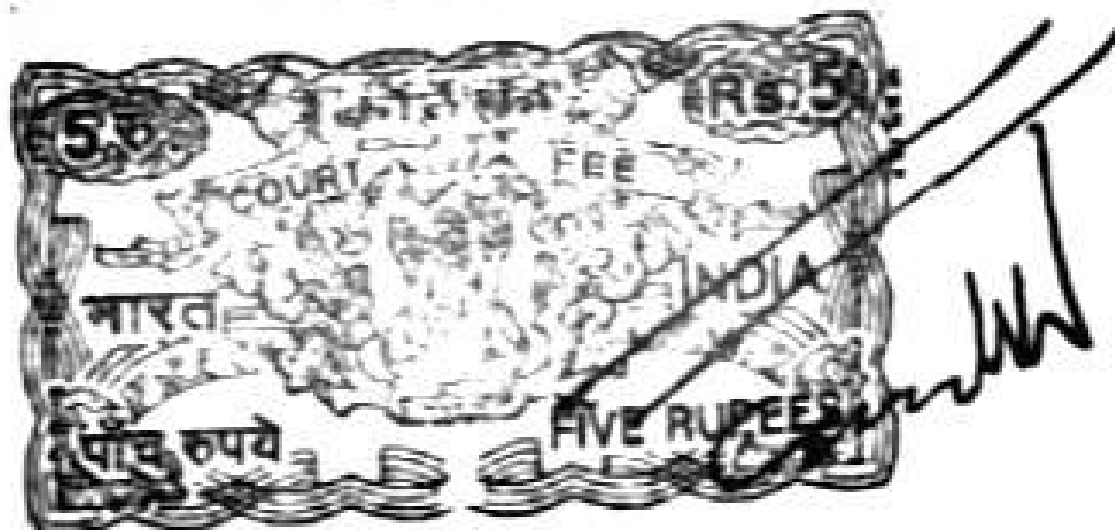

This order shall dispose the application u/s 156(3) Cr.P.C. for directing the O.C. Lilong PS for taking up necessary legal action against the accused persons for offence punishable u/s 120-B/379/420/365/341 IPC.



Heard the Ld. Counsel of the complainant via

Ld. Counsel has submitted that a complaint was filed before the O.C. Lilong PS against the accused persons dated 13/08/2020 but the OC Lilong PS did not take up any action. Thereafter, the complainant approached the SP, Thoubal by filing a complaint dated 05/12/2020 but no action has been taken up by the Police till date. An affidavit in this regard is also filed alongwith the present application. Copies of the complaint made to OC Lilong PS and SP, Thoubal are also enclosed.

The allegations are that Md. Abdur Rajak alongwith 2/3 unknown persons came at the house of the complainant and had stolen his ATM Card, Rupees ten lakh, three half tolas of gold, Patta (Dag Chitha) of his land located at Hapta measuring an area of 2.5 points and the said act was committed under a well planned criminal conspiracy with accused no. 2 who is the wife of complainant. Accused No. 1 Md. Abdur Rajak is the father-in-law of the complainant. It is also the allegation that the accused persons have also kidnapped his two daughters namely Miss Aleema Hussain Sm. (17 years) and Miss Raniya Hussian Sm (11 years) and their whereabouts are not known yet.

After considering the nature of allegations made, this Court find ground for allowing the prayer.

Accordingly, the O.C. Lilong PS is directed to investigate the case and submit a report at the earliest to the Court.

Send a copy of this order to the O.C. Lilong PS alongwith the original application after retaining photocopies of the same for record.

With this the present Cril. Misc. Case stands disposed.
