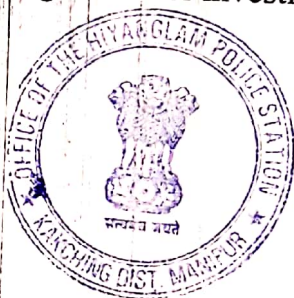



S/o A. Ningthoukaba Singh of Khekman Awang Leikai pl ying from Wabagai Lamkhai towards Sekmaijin Bazar hit one pedestrian namely Md. Maffijuddin 33yrs. S/o Md. Tomba of Santhel Mayai Leikai from the back side while he was walking by pulling his bicycle from same direction along Mayai Lambi Road at Sekmaijin Mayai Leikai near the gate of Phuritshabam Jiten Singh of Sekmaijin Mayai Leikai. As a result of which, the driver of Motor cycle pulsar B/R No. MN01B-4532 namely Asem Brajamani Singh 48yrs. S/o A. Ningthoukaba Singh of Khekman Awang Leikai and pedestrian namely Md. Maffijuddin 33yrs. S/o Md. Tomba of Santhel Mayai Leikai received injuries on their head and bodies and evacuated to Hospital for medical treatments. The Motor cycle Pulsar B/R No. MN01B-4532 & Bicycle were partly damaged.
