Subject:- Report

Sir,

I have the honour to report that today i.e. 16/02/2021 at about 2.00 pm while I was in my office, one of source man came to my office and reported that one Md. Hussain (45) S/O (L) Md. Helim of Lilong Haoreibi Turel Ahanbi is selling illegal drugs to user at his own pan shop located at his residence (premises). After verifying the veracity of the source report, I recorded the statement of the source man in writing and a copy of the said report was furnished to Officer in Charge Lilong Police Station for information. Accordingly, I obtained the search warrant from SP/TBL. Immediately, a police team of Lilong Police Station led by OC-LIL PS including woman police under the supervision of Superintendent of Police, Thoubal and source man with necessary equipment rushed at the residence of Md. Hussain (45) S/O (L) Md. Helim of Lilong Haoreibi Turel Ahanbi. On reaching the spot, the source man indicates the house including the located inside the house. So our police party cordoned the said house and family members /all the rooms of the house including the pan shop were kept under surveillance. In that one person was inside the shop located inside the house and he was detained at the shop for verification. I identified myself as police officer and my team also police personnel of Lilong PS. Then, I asked the identity of the detainee in presence of witnesses. On that he identified himself as Md. Hussain (45) S/o (L) Md. Helim of Lilong Haoreibi Turel Ahanbi. Afterwards, I offered him whether he would want his body and belongings to be searched in the presence of civil witnesses or Gazetted officer or Executive Magistrate. Then, he offered to search his body and belonging in presence of Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBL to be witness during searching the body and belonging of the above individual. On searching the body and belonging in presence of Shri H. Johny Sharma MPS SDPO-TBL as Gazetted Police Officer witness, the police team found two black polythene and one small box made of Galvanized Coated Sheet (pakshi) containing of suspected contraband Heroin No.4 at the left side corner of the shop lying on the floor. On opening one of the black polythene, the police team detected 504/-(five hundred and four) nos. of empty bottles which is used in selling illegal Heroin No.4. On opening the other black polythene, found 12 nos. of filled plastic bottle containing of suspected Heroin No.4 weighing (1) 0.9 gram (2) 1.2 gram (3) 1.1 gram (4) 1.2 gram (5) 1.2 gram (6) 1.1 gram (7) 0.9 gram (8) 0.9 gram (9) 1.1 gram (10) 0.8 gram (11) 0.9 gram (12) 1.0 gram respectively including the weight of plastic bottle container and one blue plastic packets containing 82/-(eighty two) nos. of suspected WY tablets weighing 9.5 gram including the weight of plastic container. On further opening the small box, found one green colour soap cap containing of suspected Heroin No.4 weighing 12.9 grams including the weight of plastic polythene container.

Finally all the exhibits were seized by preparing a formal weighing and seizure memo at 3.30 pm from the possession of Md. Hussain (45) S/O (L) Md. Helim of Lilong Haoreibi Turel Ahanbi and arrested the accused person Md. Hussain (45) S/O (L) Md. Helim of Lilong Haoreibi Turel Ahanbi by preparing formal a arrest memo at 3.40 pm.

Then, I obtained the signature of the arrestee and witnesses on the seizure memo, arrest memo in which I myself also put my signature on the same.

The arrested person along with seized items are brought to police station for taking further necessary legal action against him.
