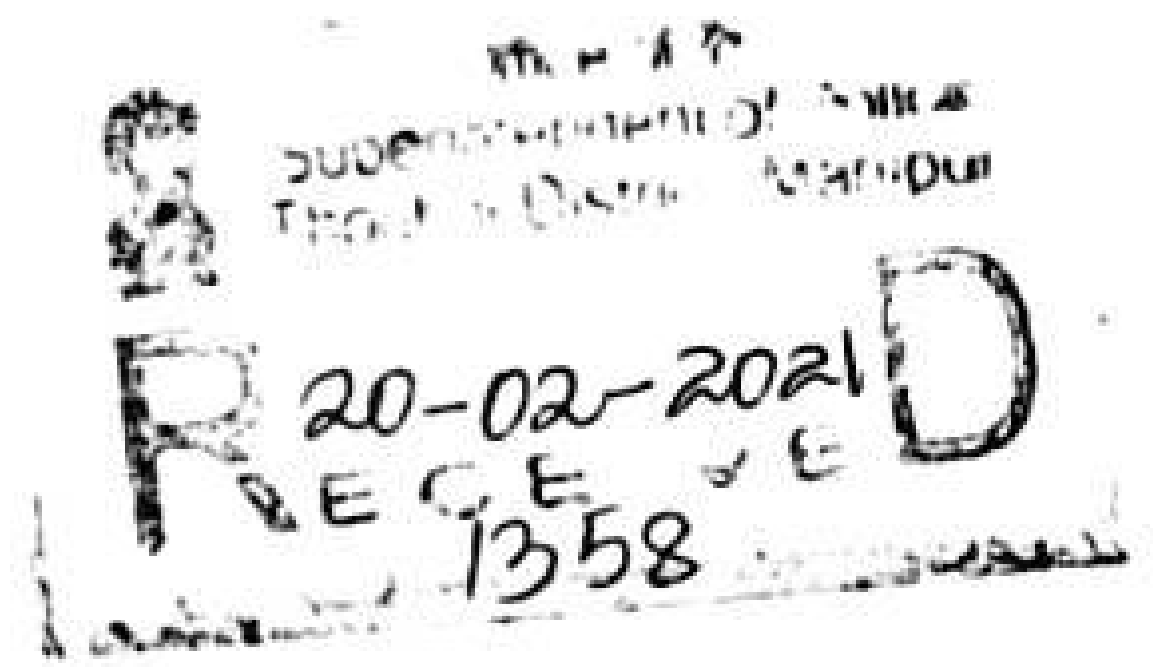

With due respect, I, the undersigned applicant would like to submit the following few lines for your kind consideration and necessary affirmative action.

1. That, I am the widow of one deceased Md. Sabir Khan, who died in an ambush in the year 2002, while he was serving as a Rifleman in IRB.
2. That, my son namely, Md. Satish Khan and his wife Mrs. Sultana were Talak on 21-12-2020 by executing a Talak Nama.
3. That, on 20-01-2021, due to the said Talak one Md. Rafijuddin, aged about 35 years, S/o (late) Kd. Karimdin Haji of Lilong Ubakthong Mathak, P.S. Lilong, District- Thoubal, Manipur, rebuked me before my localities as well as his localities by using many slang languages like that I am a prostitute and my husband was died due to being a husband of prostitute.

4. That, recently on 25-01-2021, in the evening, I along with my younger sister namely, Samina, W/o Md. Bulam of Lilong Ubakthong

Mathak were standing in front of her gate, Md. Rafijuddin again rebuked me before my younger sister that I am a prostitute and I had killed by husband. I told him not to use such language otherwise I will complaint to the Police Station.

5. That, Md. Rafijuddin without any hesitation he pushed me into the drain and attempted to hit me by using a stick (log). However, due to strong intervention by my younger sister he failed to do so. On the same day i.e. 25-01-2021, he further told me that I will face dire consequences if I disclosed the matter to Police or local bodies.

6. That, on the same day i.e. 25-01-2021, in the late evening, I went to the Lilong Police Station and orally informed the matter. However, no any legal necessary action against Md. Rafijuddin till date.

In the above circumstances, I have apprehension that Md. Rafijuddin may attack me at any time. Therefore, I request your goodself to take necessary legal action against Md. Rafijuddin in the above circumstances so as not to cause irreparable injury to me, in the interest of justice.

Please do the needful at the earliest.
