Subject:- Report

Sir,

I have the honour to report that today i.e. 23/02/2021 at about 3.00 pm Head Constable W. Premananda Singh of CDO/TBL informed me that one of his source man gave him an information that one Mrs. Khursida Begum (28) W/O Md. Shurjad of Lilong Ushoipokpi Tharaorok and one Mrs. Sumabi (26) W/O Md. Ziaul Haque of Lilong Ushoipokpi Tharaorok were running drug vendor and selling illegal drugs to abusers at their residence (premises). Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to me by Head Constable W. Premananda Singh of CDO/TBL for kind information and further necessary action. So, I obtained the search warrant from Superintendent of Police, Thoubal. Immediately, organized a combined team of CDO/TBL led by me and Lilong Police Station team led by OC LIL PS including woman police under the supervision of Additional Superintendent of Police, Thoubal (Ops) under the overall supervision of Superintendent of Police, Thoubal and source man with necessary equipments rushed at the residence of Mrs. Khursida Begum (28) W/O Md. Shurjad of Lilong Ushoipokpi Tharaorok and Mrs. Sumabi (26) W/O Md. Ziaul Haque of Lilong Ushoipokpi Tharaorok. On reaching the spot, the source man indicates the residence (drug vendor). Our police party cordoned the said residence and found two woman inside the house and they were detained for verification. I identified myself as police officer and my team also police personnel of CDO/TBL and Lilong PS team. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that they identified themselves as Mrs. Khursida Begum (28) W/O Md. Shurjad of Lilong Ushoipokpi Tharaorok and Mrs. Sumabi (26) W/O Md. Ziaul Haque of Lilong Ushoipokpi Tharaorok. Afterwards, I offered them whether they would want their body and belongings to be searched in the presence of civil witnesses or Gazetted officer or Executive Magistrate. In that, they offered to search their body and belonging in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBL to be witness during searching the body and belonging of the above individuals. On searching the body and belonging in presence of Shri H. Johny Sharma, MPS, SDPO-TBL as Gazetted Police Officer witness including woman police, the police team found two green colour polythene and one of polythene was found containing 20/(twenty)nos of bottles of 100 ml capacity of of suspected Chlorpheniramine Maleate & Codeine Phosphate Syrup and another polythene was found containing 17/(seventeen) nos of empty bottles of 100 ml capacity marked as Chlorpheniramine Maleate & Codeine Phosphate Syrup under the bed of Mrs. Sumabi inside


the two buckets, one blue in colour and another orange in colour. On further searching the godrej, found 9/(nine) nos of small plastic bottle container containing of suspected Heroin No.4 weighing (1) 0.8 gram (2) 0.8 gram (3) 0.8 grams (4) 0.8 gram (5) 0.7 grams (6) 1.6 gram (7) 1.2 gram(8) 2.4 grams (9) 0.7 grams respectively including the weight of container and 17/(seventeen) nos of empty small plastic bottle container, one plastic bottle marked as Alzyme containing of suspected Heroin No.4 weighing 27.4 grams including the weight of container and 2(two) empty soap caps, one red in colour and another green/blue in colour and 40/(forty) nos of empty small plastic bottles container and one small box made of Galvanized Coated Sheet(Paksi) containing a sum of Rs. 36150/ (thirty six thousand one hundred and fifty) which is the sale proceed money of illegal drugs. On further searching under the bed of Mrs. Khursida, found one black polythene containing 1258/(one thousand two hundred and fifty eight) nos of suspected Spasmo Proxivon (SP) capsule weighing 751 gram including the weight of container.


Finally all the exhibits were seized by preparing a formal weighing and seizure memo at 4.30 pm and 4.40 pm from the possession of Mrs. Khursida Begum (28) W/O Md. Shurjad of Lilong Ushoipokpi Tharaorok and Mrs. Sumabi (26) W/O Md. Ziaul Haque of Lilong Ushoipokpi Tharaorok and arrested the accused person Mrs. Khursida Begum (28) W/O Md. Shurjad of Lilong Ushoipokpi Tharaorok and Mrs. Sumabi (26) W/O Md. Ziaul Haque of Lilong Ushoipokpi Tharaorok by preparing formal a arrest memo at 5.00 pm and 5.10 pm respectively.

Then, I obtained the signature of the arrestee and witnesses on the seizure memo, arrest memo in which I myself also put my signature on the same.

The arrested person along with seized items are handed over to you for taking further necessary legal action against them.
