Sir,

I have the honour to report that on 01/03/2021 at about 05.30 pm my son namely Md. Salman Khan aged about 20 yrs. went to the house of his legal wife namely Mrs. Fatima aged about 19 yrs. d/o Md. Mutim resident of Lilong Khongban. On the same day at about 06:45 pm, I came to know that my son Md. Salman Khan had been stabbed by his wife (Fatima) at her residence using a pointed knife with intention to kill him. So, I along with my family members rushed to the house of Mrs. Fatima and found my son at the residence of said Mrs. Fatima with bleeding injury on his abdomen. Immediately, he was evacuated to hospital for medical treatment. It is learnt that my son had been stabbed by Mrs. Fatima in collusion with her family members.

It is therefore requested to take necessary legal action against the culprits at the earliest.
