

I have the honour to report that on 03/03/2021 at about 05:10 pm while my younger brother namely Md. Habibur Rahaman aged about 35 yrs s/o (L) Md. Meinoruddin of Lilong Turel Ahanbi Boroimakhong was coming back his home after taking money from someone on the way reaching at Lilong Uku near Oil Pump, Lilong, the abovementioned accused persons restrained my brother and physically assaulted him without giving any reason. Further they extorted a sum of Rs. 32,000/- from him and fled away quickly. As a result of which, he sustained injury on his persons and evacuated to the hospital for medical treatment.

So, I therefore request, that you may kindly take necessary against the above cited culprit at the earliest.
