I have the honour to report that ~~on~~ 09/03/2021 at about 04.15pm, while I along with my elder sister namely Khursida @ Ebemcha 36yrs were coming on a Honda Dio along the IVR of Lilong Haoreibi Turel Ahanbi; one Md. Tajuddin 38yrs S/o Late Md. Fajur Rahman @ Tonjao of Lilong Yangbi Leikai stop me at near the gate of Md. Kayamuddin S/o Late Md. Kasim Ali of Lilong Yangbi Leikai. Then, he used slang words to us and consequently he along with Md. Firoj Khan 24yrs S/o Late Md. Fajur Rahman @ Tonjao of Lilong Yangbi Leikai along with unknown 4/5 persons assaulted me and my elder sister without any reason by holding Iron brush. As a result of which I along with my elder sister received injuries on our persons and evacuated to Hospital for Medical Treatment.

Therefore you may kindly take further necessary action against them.
