

I have the honour to report that on 09/03/2021 at around 02:30 am, my two wheeler Honda Activa 4G red in colour bearing registration no. MN06SB-4327 having engine no. JF50E75013322 & chassis no. ME4JF507CH7013335, registered in the name of Ajmir Khan Makakmayum s/o M.V. Yakib Ali a resident of Lairabakhong Ashem Leirak, Lilong which was parked under lock and key from the garage of my house located at Lilong Haoreibi Makha Leikai Lairabakhong had been stolen away by unknown person/persons. Moreover one mobile handset "Redmi 4" having IMEI No. 866760037498526 fitted with one sim card bearing no. 6909992053 (airtel) was also stolen away while it was charging inside my room. The same are untraceable till date despite of vigorous efforts.
