




Sir,

I have the honour to report that today i.e. 13/03/2021 at about 2.00 pm while I was in my office, one of my source man informed that one Mrs. Sultana (33) W/O (L) Md. Ishak of Lilong Mairenkhun A/P Lilong Haoreibi Turel Ahanbi Ubakthong Makha was running drug vendor and selling illegal drugs to abusers at her residence (premises). Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Lilong Police Station for kind information and further necessary action. Accordingly, I obtained the search authorization from Superintendent of Police, Thoubal. Immediately, organized a combined team of CDO/TBL and Lilong Police Station team led by OC LIL PS including woman police and ALADA member under the supervision of Superintendent of Police, Thoubal with necessary equipment rushed at the residence of Mrs. Sultana (33) W/O (L) Md. Ishak of Lilong Mairenkhun A/P Lilong Haoreibi Turel Ahanbi Ubakthong Makha. On reaching the spot, our police party cordoned the said residence and found one woman inside the house and she was detained for verification. I identified myself as police officer and my team also police personnel of CDO/TBL and Lilong PS team. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that she identified herself as Mrs. Sultana (33) W/O (L) Md. Ishak of Lilong Mairenkhun A/P Lilong Haoreibi Turel Ahanbi Ubakthong Makha. Afterwards, I offered her whether she would want her body and belongings to be searched in the presence of or Gazetted officer or Executive Magistrate. In that, she offered to search her body and belonging in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBL to be witness during searched of body and belonging of the above individual. On searching the body and belonging in presence of Shri H. Johny Sharma, MPS, SDPO-TBL as Gazetted Police Officer witness including woman police, the police team found no incriminating articles from her possession. On further searching the belonging, found one soap cap containing two small plastic polythene of suspected Heroin weighing 25.4 gram including the weight of polythene container inside the rice pot (chengphu) and 370 nos. of small plastic container from the chicken coop. On examination, she disclosed that she along with Md. Abdul Noor@ Mustaque (26) S/O Md. Abdul Samad of Lilong Haoreibi Turel Ahanbi Ubakthong Makha Leikai were running drug vendor at the residence of Md. Abdul Noor@ Mustaque and he is absconding from police arrest.

Finally the exhibits was seized by preparing a formal weighing and seizure memo at 3.30 pm from the possession of Mrs. Sultana (33) W/O (L) Md. Ishak of Lilong Mairenkhun A/P Lilong Haoreibi Turel Ahanbi Ubakthong Makha and arrested the accused person Mrs. Sultana (33) W/O (L) Md. Ishak of Lilong Mairenkhun A/P Lilong Haoreibi Turel Ahanbi Ubakthong Makha by preparing formal arrest memo at 3.40 pm.

The arrested person along with seized items is handed over to you for taking further necessary legal action against her.
