


Sir,

I have the honour to report that today i.e. 13/03/2021 at about 8.10 pm while I was in my office, one of my source man informed that one Md. Minhajuddin (30) S/O (L) Md. Karimuddin of Lilong Sambrukhong Mamei was running drug vendor and selling illegal drugs to abusers at his residence (premises). Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Lilong Police Station for kind information and further necessary action. Accordingly, I obtained the search authorization from Superintendent of Police, Thoubal. Immediately, Lilong Police Station team led by OC LIL PS including woman police and ALADA member under the supervision of Superintendent of Police, Thoubal with necessary equipments rushed at the residence of Md. Minhajuddin (30) S/O (L) Md. Karimuddin of Lilong Sambrukhong Mamei. On reaching the spot, our police party cordoned the said residence and found one person inside the house and he was detained for verification. I identified myself as police officer and my team also police personnel of Lilong PS team. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that he identified himself as Md. Minhajuddin (30) S/O (L) Md. Karimuddin of Lilong Sambrukhong Mamei. Afterwards, I offered him whether he would want his body and belongings to be searched in the presence of Gazetted officer or Executive Magistrate. In that, he offered to search his body and belonging in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBL to be witness during searched of body and belonging of the above individual. On searching the body and belonging in presence of Shri H. Johny Sharma, MPS, SDPO-TBL as Gazetted Police Officer witness including woman police, the police team found no incriminating articles from his possession. On further searching the belonging, found one small poythene containing of suspected Heroin weighing 24.6 gram including the weight of container under his bed.

Finally the exhibits was seized by preparing a formal weighing and seizure memo at 9 30 pm from the possession of Md. Minhajuddin (30) S/O (L) Md. Karimuddin of Lilong Sambrukhong Mamei and arrested the accused person Md. Minhajuddin (30) S/O (L) Md. Karimuddin of Lilong Sambrukhong Mamei by preparing formal a arrest memo at 9.40 pm.

The arrested person along with seized items are handed over to you for taking further necessary legal action against him.
