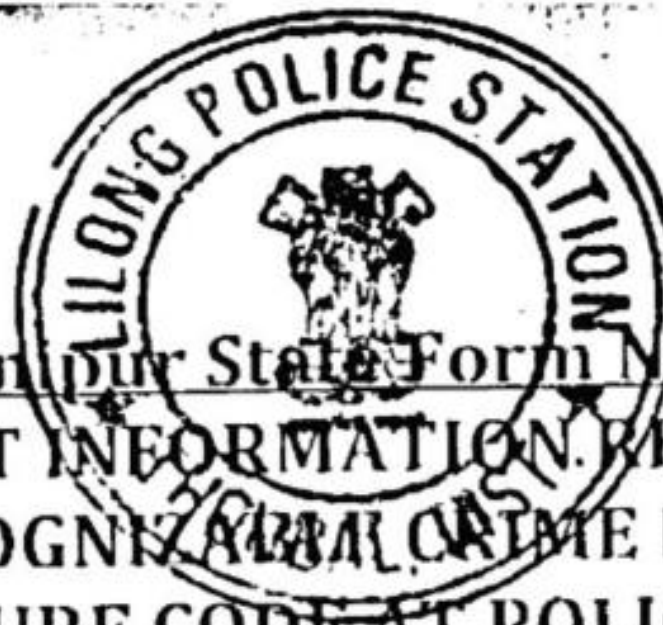

Subject:- Report

Sir,

I have the honour to report that today i.e. 13/04/2021 at about 2.30 pm while I was in my office, one of my source man informed that one Mrs. Makakmayum Rina (29) D/o Md. Abdul Kalam of Lilong Tharaorok Chingon was running drug vendor and selling illegal drugs to abusers at Lilong Tharaorok village IVR crossing near NH 102 by impersonating herself as running vegetable vendors. Accordingly, after verifying the veracity of source report, the information was taken down in writing and a copy of the same was forwarded to Officer in Charge, Lilong Police Station for kind information and further necessary action. Accordingly, I obtained the search authorization from Superintendent of Police, Thoubal. Immediately, Lilong Police Station team led by OC/LIL-PS including woman police under the supervision of Superintendent of Police, Thoubal with necessary equipments rushed at the vegetable vendor located at Lilong Tharaorok village IVR crossing near NH 102. On reaching the spot, our police party saw one woman was selling vegetables at Lilong Tharaorok and she was detained for verification. Then, I asked the identity of the detainee in presence of the woman police and other witnesses. On that she identified herself as Mrs. Makakmayum Rina (29) D/o Md. Abdul Kalam of Lilong Tharaorok Chingon. Afterwards, I offered her whether she would want her body and belongings to be searched in the presence of Gazetted officer or Executive Magistrate. In that, she offered to search her body and belonging in presence of a Gazetted officer as witnesses. Accordingly, I informed Shri H. Johny Sharma, MPS, SDPO-TBL to be witness during searched of body and belonging of the above individual. On searching the body and belonging in presence of Shri H. Johny Sharma, MPS, SDPO-TBL as Gazetted Police Officer witness including woman police, the police team found one black polythene under her clothing and one lady hand bag containing a sum of Rs. 2530/- (two thousand five hundred and thirty) which is the sale proceed of illegal drugs. On opening the black polythene, found 24/(twenty four) nos. of small plastic bottle container containing of suspected Heroin weighing 30.8 grams including the weight of container. On further searching the belonging, found one small black polythene inside the wall of vegetable vendors. On opening, found 108/- (one hundred and eight) nos. of small plastic bottle container containing of suspected Heroin weighing 1253 grams including the weight of container.

Finally the exhibits was seized by preparing a formal weighing and seizure memo at 3.30 pm from the possession of Mrs. Makakmayum Rina (29) D/o Md. Abdul Kalam of Lilong Tharaorok Chingon and arrested the accused person Mrs. Makakmayum Rina (29) D/o Md. Abdul Kalam of Lilong Tharaorok Chingon by preparing formal a arrest memo at 3.40 pm.

The arrested person along with seized items are handed over to you for taking further necessary legal action against her.
